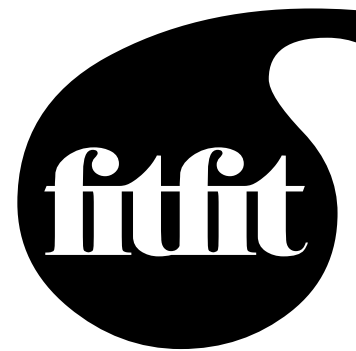


# Terms & Conditions

Terms and Conditions of sale



These Conditions set out the basis on which we provide riding full chaps for sale. We are Mitchelswood EC (VAT number 750 2253 64), trading as fitfit.co.uk. Our principal place of business is Mitchelswood Farm, Newick, Lewes, Sussex BN8 4NH.

Definitions of certain words used in these Conditions can be found in paragraph 11 of these Conditions.

1 **Acknowledgement & Acceptance of Order**  
No contract will exist between you and us until we have received full payment from you and have given you a written or emailed acceptance of your order. We reserve the right to decline any order.

2 **Payment**  
Payment for the Goods is due at the same time you place your order. No Goods will be dispatched until you have paid us in full for the corresponding order. Cheques will be cleared through the bank before goods are dispatched.

3 **Cancellation**  
You have the right to cancel this Contract by giving us notice of cancellation at any time up to 14 days after delivery of the Goods. If you wish to exercise your right to cancel, please contact us as soon as possible (see paragraph 9, "Communications").

If you cancel this Contract you are responsible for returning to us, at your own expense, any Goods received by you under this Contract. The Goods must be returned to us in perfect condition within 14 days of cancellation. If you fail to return the Goods within 14 days of cancellation then we may collect the Goods from you, and charge you our direct costs for recovering the Goods.

4 **Quality**  
If any Goods we supply to you fail to meet the high standard of quality and workmanship you expect from us, you should return the Goods to us as soon as a fault is discovered (see paragraph 9, "Communications"). This does not affect your statutory rights. If we agree that the Goods have been used as directed in this Contract but are not of the standard you can expect from us, we will reimburse the costs of returning the Goods to us and, at our expense, arrange for either repaired or, at our discretion, replacement Goods to be sent to you.

If the Goods are ordered in an incorrect size, you should return the Goods to us, at your own expense, notifying us of the correct size required. The Goods must be as delivered and unused. Additional postage and packing charges will be made for replacement Goods.

5 **Use of Goods**  
The full chaps have been designed to be suitable for use when horse riding. They are not intended to be a substitute for standard safety equipment. The mobile telephone pocket is provided for convenience only and we will not be liable for any damage caused to any items stored in the pocket. The Goods must be treated in accordance with instructions on the care label.

6 **Ownership of intellectual property rights**  
We own, and shall own, all intellectual property rights in or relating to the Goods.

7 **Law**  
This Contract is governed by English Law. The Goods are only available for delivery in the United Kingdom and the Republic of Ireland except as specified below.

**“you”, “your”:** the customer who is entering into the Contract on the basis of these Conditions.
